#### Approval of the Minutes from the Regular Board Meeting.

Commissioner Santalucia made a motion, seconded by Commissioner Morrocco to approve the minutes of the March 9, 2023 Board Regular Board Meeting. The motion passed unanimously.

Commissioner Santalucia made a motion, seconded by Commissioner Marrocco to approve the Accounts Payables as presented. The motion passed unanimously.

Commissioner Santalucia made a motion, seconded by Commissioner Marrocco, to approve the Certificate of Final Completion (CFC) for Alpha Contracting Associates, Inc. for the Comprehensive Building Envelope Repairs Phase 5 at Buildings 15 & 16 and authorize Final payment in the amount of \$13,212.38. The motion passed unanimously.

Commissioner Santalucia made a motion, seconded by Commissioner Marrocco, to award and authorize the Executive Director to enter into a contract with Harrison Electric, LLC for the Fire Alarm System Upgrade at Woodbine Ave. 167-1, FISH @ 123066. The Plans and Specifications were prepared by John Murphy Electrical Construction and Engineering, Inc. The Bids were opened on March 22, 2023. Five bids were received. Harrison Electric, LLC was the low bidder. The contract will be in the amount of \$38,500.00. The source of funding for this contract is DHCD Formula Funding. The motion passed unanimously.

Commissioner Santalucia made a motion, seconded by Commissioner Marrocco, to approve the Certificate of Final Completion (CFC) for Alpha Contracting Associates, Inc. for the

Comprehensive Building Envelope Repairs Phase 4 at Buildings 1 & 2 and 13 & 14 and authorize Final payment in the amount of \$19,427.50. The motion passed unanimously.
